



TUITION RATES for Full Year Programs: Effective February 1, 2018

We offer a **7% discount for monthly payments and a 10% for quarterly payments (NEW) using Bank Direct Debit (ACH)**. If you are interested in monthly or quarterly billing, please contact Andrew Sambrook at sambrook@annettespreschool.com or 914 441 8811.

We do not accept credit card payments. A non-refundable registration fee of \$70 for new families.

Nursery/Mobile Infant/Toddler Program (6 weeks – placement in Preschool)

\$285 per week paid weekly

\$1150 per month paid monthly on 1st of month. **7% discounts over weekly rates, (\$1020 savings per year!)**

\$3335 per quarter payable Mar 1, June 1, Sep 1, Dec 1. **10% discounts over weekly rates, (\$1480 savings per year!)**

NOTE: **Full Time enrollment Only** in the Nursery Program unless otherwise arranged with the Director.

\$75 per day for Mobile Infant and Toddler Programs (daily rate requires a minimum of 2 days)

\$605 per Month for enrolling 2 days/week (Monthly rate – 7% discount over weekly rates)

\$906 per Month for enrolling 3 days/week (Monthly rate – 7% discount over weekly rates)

NOTE: **Toddler rates will continue to apply for children thru August 31 of the year preceding Preschool i.e. until they qualify for Act 166 funding as of September 1 of that year.**

Preschool Program (3 to 5 years) – Full Day Program prequalified for Act 166 Funding

NOTE: Act 166 credits of \$3267 for 2018/19 will cover 10 hours per week for all preschoolers who will be age 3 on or before September 1, 2018.

Weekly payors! – a 52-week flat rate billing during year for 12 month enrollees (including summer)

Net Tuition of \$230 per week paid weekly AFTER credit for 2018/19 Act 166 funding of \$3267 or \$77.78/week. The same flat rate through the year!

If not eligible for Act 166 or not enrolled for full year, the full tuition rate of \$307.78/week will be applied.

Monthly Payors! – a 12-month flat rate billing during year for 12 month enrollees (including summer)

7% discount for monthly billing, **(\$836 savings per year!)**

Net Tuition of \$927 per month paid monthly on 1st of month AFTER credit for 2018/19 Act 166 funding of \$3267 or \$326.70/month. The same flat rate through the year!

If not eligible for Act 166 or not enrolled for full year, the full tuition rate of \$1253.70/month will be applied.

Quarterly Payors! – a 4-quarter flat rate billing during year for 12 month enrollees (including summer)

10% discount for monthly billing, **(\$1200 savings per year!)**

Net Tuition of \$2690 per quarter paid quarterly on 1st of March/June/Sept/Dec AFTER credit for 2018/19 Act 166 funding of \$3267 or \$816.75/quarter. The same flat rate through the year!

If not eligible for Act 166 or not enrolled for full year, the full tuition rate of \$3506.75/quarter will be applied.

Part-Week Option!

\$60 per day (part week preK requires a minimum of 2 days) – AFTER credit for Act 166 funding

\$484 per Month for enrolling 2 days/week (Monthly rate – 7% discount over weekly rates).

\$725 per Month for enrolling 3 days/week (Monthly rate – 7% discount over weekly rates).

TUITION RATES for *Part Year* Programs: Effective February 1, 2018

School Age Program (Ages 5 - 8) – School Year 2017/18 (limited to 20 participants!)
--

All Day HCS vacation/HCS in-service days (from Sept 1, 2018)

Winter and Spring Breaks	\$200/ 5 days
Other HCS Vacation and Inservice Days	\$ 40/ day

After School (2:30 dismissal from HCS: M, W, Th, Fr and 1:30 dismissal on T)

Daily	\$ 18/ day(min. 2 days)
Weekly	\$ 90/week
Monthly (charged at 4 x weekly rate)	\$ 360/month (M-F); \$72/ day.mo

Note that the School Age Monthly rates are calculated at 4 x the weekly rates. The 7% monthly discount for our other programs is **NOT** applicable to these rates.

Note: Full Rates for the 2019 Summer Camp will be published in early Spring 2018. The rates for the 2018/19 school year will be published in June 2018.

Preschool Program (3 to 5 years) – AM Part Day Program prequalified for Act 166 Funding
--

*We require a one-time **returnable** deposit of \$230 and a **non-returnable** registration fee of \$70 upon registration for our Part Day program.*

Minimum enrollment of 3-half days.(10 hours/week)

NOTE: Act 166 credits of \$3267 will cover the FULL Tuition for 10 hours/wk of our 35-week program for children who will be age 3 on or before September 1, 2018. This program follows the CVSD (Champlain Valley School District) school calendar.

Additional days will be charged as follows:

For enrolling **4 half days/week** -- **\$40/week** for 35 weeks or **\$149/month** for 10 months (Monthly rate – 7% discount over weekly rates)

For enrolling **5 half days/week** -- **\$72/week** for 35 weeks or **\$234/month** for 10 months (Monthly rate – 7% discount over weekly rates)

For those families that enter the program during the year but **do not** qualify for Act 166 funding, the tuition will be **\$120/week** or **\$390/month** for enrolling **3 half days/week**.
