



TUITION RATES for Full Year Programs: Effective February 1, 2017

NEW! For 2017!! We now offer a **7% discount for monthly payments using Bank Direct Debit (ACH)**, If you are interested in monthly billing, please contact our Business Director, Victoria Ward on 482-2525.

Unfortunately, due to additional costs we will not be accepting credit card payments for weekly or monthly tuition payments after January 31, 2017

Nursery/Mobile Infant/Toddler Program (6 weeks – placement in Preschool)

\$260 per week paid weekly

\$1048 per month paid monthly on 1st of month

7% discount over weekly rates, **(\$944 savings per year!)**

NOTE: **Full Time enrollment Only** in the Nursery Program unless otherwise arranged with the Director.

\$68 per day for Mobile Infant and Toddler Programs (daily rate requires a minimum of 2 days)

\$548 per Month for enrolling 2 days/week (Monthly rate – 7% discount over weekly rates)

\$822 per Month for enrolling 3 days/week (Monthly rate – 7% discount over weekly rates)

Preschool Program (3 to 5 years) – Full Day Program prequalified for Act 166 Funding

NOTE: Act 166 credits of \$3178 for 2017/18 will cover 10 hours of full time program for all preschoolers who will be age 3 on or before September 1, 2017.

Weekly payors! – a 52-week flat rate billing during year for 12 month enrollees (including summer)

Net Tuition of \$210 per week paid weekly AFTER credit for 2017/18 Act 166 funding of \$3178 or \$75.67/week.

Full Tuition (before applying Act 166) is \$285.67/week during school year (42 weeks) and \$210/week during summer (10 weeks). If not eligible for Act 166 or not enrolled for full year the full tuition rates will be applied.

Monthly Payors! – a 12-month flat rate billing during year for 12 month enrollees (including summer)

7% discount for monthly billing, **(\$768 savings per year!)**

Net Tuition of \$846 per month paid monthly on 1st of month AFTER credit for 2017/18 Act 166 funding of \$3178 or \$317.80/month.

Full Tuition (before applying Act 166) is \$1163.80/month during school year (10 months) and \$846/month during summer (2 months). If not eligible for Act 166 or not enrolled for full year the full tuition rates will be applied.

Part-Week Option!

\$55 per day (part week preK requires a minimum of 2 days) – AFTER credit for Act 166 funding

\$443 per Month for enrolling 2 days/week (Monthly rate – 7% discount over weekly rates).

\$665 per Month for enrolling 3 days/week (Monthly rate – 7% discount over weekly rates).

TUITION RATES for Part Year Programs: Effective February 1, 2017

School Age Program (Ages K - 12) – School Year 2016/17 (Current Year)

All Day HCS vacation/HCS in-service days) – NO INCREASE for Current School Year!

Spring and February Breaks	\$175/ 5 days
Other HCS Vacation and Inservice Days	\$ 35/ day

After School (2:30 dismissal from HCS: M,W,Th,Fr and 1:30 dismissal on T) – NO INCREASE for Current School Year!

Daily	\$ 17/ day(min. 2 days)
Weekly	\$ 85/week
Monthly (charged at 4 x weekly rate)	\$ 340/month (M-F); \$68/ day.mo

Note: Full Rates for the following School Year 2017/18 (starting Aug 2017) and the 2017 Summer Camp will be published in early Spring/Summer

Preschool Program (3 to 5 years) – AM Part Day Program prequalified for Act 166 Funding

*We require a one-time **returnable** deposit of \$210 and a registration fee of \$60 upon registration for our Part Day program.*

Minimum enrollment of 3-half days.(10 hours/week)

NOTE: Act 166 credits of \$3178 will cover the FULL Tuition for 10 hours/wk of our 35-week program for all enrolled preschoolers enrolled who will be age 3 on or before September 1, 2017. This program follows the CSSU school calendar.

Additional days will be charged as follows:

For enrolling **4 half days/week** -- **\$35/week** for 35 weeks or **\$114/month** for 10 months (Monthly rate – 7% discount over weekly rates)

For enrolling **5 half days/week** -- **\$65/week** for 35 weeks or **\$211/month** for 10 months (Monthly rate – 7% discount over weekly rates)

For those families that enter the program during the year but **do not** qualify for Act 166 funds, the tuition will be **\$105/week** or **\$342/month** for enrolling **3 half days/week**.
