



TUITION RATES for Year Round Programs: Effective February 1, 2016

For 2016, we are continuing the option to pay monthly via ACH (bank account). **We have reduced the weekly equivalent rates by 5% for those that choose this option.** If you are interested in monthly billing, please contact our Business Director, Victoria Ward on 482-2525.

Nursery/Mobile Infant/Toddler Program (6 weeks – placement in Preschool)

\$250 per week paid weekly

\$1030 per month paid monthly on 1st of month – *5% discount over weekly rates*

NOTE: **Full Week Only** in the Nursery Program unless otherwise arranged with the Director.

\$65 per day for Mobile Infant and Toddler Programs (daily rate/part week care requires a minimum of 2 days)

\$535 per Month for enrolling 2 days/week (Monthly rate - *5% discount over weekly rates*)

\$800 per Month for enrolling 3 days/week (Monthly rate - *5% discount over weekly rates*)

Preschool Program (3 to 5 years) – Full Day Program prequalified for Act 166 Funding

NOTE: Act 166 credits of \$3092 for 2016/17 will cover 10 hours of full time program for all qualified preschoolers enrolled who will be age 3 on or before September 1, 2016.

For remainder of school year 2015/16...transitional year (2/1/16 thru 6/10/16)

\$250 per week paid weekly BEFORE credit for 2015/16 Act 166 funding of \$3000.

\$1030 per month paid monthly on 1st of month (*5% discount over weekly rates*) BEFORE credit for 2015/16 Act 166 funding of \$3000.

NOTE: All remaining 2015/16 Act 166 credits for 2015-2016 school year will be applied to accounts according to current schedule -- please ask Victoria for more information

\$65 per day for Preschool Program (daily rate/part week care requires a minimum of 2 days)

\$535 per Month for enrolling 2 days/week (Monthly rate - *5% discount over weekly rates*).

\$800 per Month for enrolling 3 days/week (Monthly rate - *5% discount over weekly rates*).

Starting 6/10/2016...New for 2016/17! – – a 52-week flat rate billing

Net Tuition of \$195 per week paid weekly AFTER credit for 2016/17 Act 166 funding of \$3092 or \$73.62/week.

Full Tuition (before applying Act 166) is \$268.62/week during school year (42 weeks) and \$195/week during summer (10 weeks). If not eligible for Act 166 the full tuition rates will be applied.

Starting 6/10/2016...New for 2016/17! – – a 12-month flat rate billing during year (with 5% discount for monthly billing)

Net Tuition of \$800 per month paid monthly on 1st of month AFTER credit for 2016/17 Act 166 funding of \$3092 or \$309.20/month.

Full Tuition (before applying Act 166) is \$1109.20/month during school year (10 months) and \$800/month during summer (2 months). If not eligible for Act 166 the full tuition rates will be applied.

\$50 per day (part week care requires a minimum of 2 days) – AFTER credit for Act 166 funding

\$412 per Month for enrolling 2 days/week (Monthly rate - *5% discount over weekly rates*).

\$618 per Month for enrolling 3 days/week (Monthly rate - *5% discount over weekly rates*).

TUITION RATES for Part Year Programs: Effective February 1, 2016

School Age Program (Ages 5 - 12) – School Year 2015/16

All Day (vacation/HCS in-service days) – NO INCREASE for School Year!	\$175/ 5 days \$ 38/ day
After School (2:30 dismissal from HCS) – NO INCREASE for School Year!	\$ 18/ day - \$80/week \$320/month (M-F); \$64/ day.mo

Preschool Program (3 to 5 years) – Part Day Program prequalified for Act 166 Funding

Minimum 3-half day enrollment.

NOTE: Act 166 credits of \$3092 will cover 10 hours of our 35-week program for all qualified preschoolers enrolled who will be age 3 on or before September 1, 2016. This program follows the CSSU school calendar.

Additional days will be charged as follows:

For enrolling **4 days/week** -- **\$30/week** for 35 weeks or **\$100/month** for 10 months (Monthly rate - 5% discount over weekly rates)

For enrolling **5 days/week** -- **\$60/week** for 35 weeks or **\$200/month** for 10 months (Monthly rate - 5% discount over weekly rates)

For those families that enter the program during the year but **do not** qualify for Act 166 funds, the tuition will be **\$90/week** or **\$300/month** for enrolling **3 days/week**.
